FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in CSR CHILDREN'S FOUNDATION, INC. event and related activities. I, for myself, my successors, heirs, assigns, executors, administrators, spouse, and next of kin:

1. Agree that prior to participating in the event or activity I will inspect the facilities, equipment, and areas where the event or activity is being conducted and, if I believe any of them are unsafe, I will immediately advise the person supervising the event, facility or area.
2. Acknowledge that I fully understand that the my participation may involve risk of serious injury or death, including economic losses, which may result not only from my own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of play for this type of event or activity.

Release, waive, discharge and relinquish CSR Children's Foundation, Inc., All other sponsors (Permittee/Sponsor), The City of Long Beach, and their officers, employees, and agents from any liability, loss, demand or cause of action against them attributable to my participation in the event or activity is being conducted, the rules of play for this type of event or activity.

Assume any and all risk of personal injuries to me and authorize the City of Long Beach or the Permittee/Sponsor to contact or employ a licensed physician to render any medical treatment that may be deemed necessary for myself or to take and admit me to any hospital. If such medical treatment or hospitalization is required. I agree to pay all medical and hospital bills relating thereto permanent or partial disability, or death and damages to the minor's or my property, caused by or arising from my participation in the event or activity.

Covenant not to use present any claim for personal injury, property damage, or wrongful death for or against the CSR Children's Foundation Inc., all remaining Sponsors Permittee /Sponsor of the City of Long Beach and their officers, employees, and agents attributable to my participation in the event or activity.

Agreement that photographs, pictures, slides, movies, or videos may be taken in connection with my participation in the event of activity without compensation from the CSR Children's Foundation, Inc., All remaining Sponsors Permittee/Sponsor of the City of Long Beach and consent the use of photographs.
7. Warrant that I am in good health and have no physical condition that would prevent me from participation in the event or activity.
